E-MAIL/INTERNET/CHROMEBOOK REGULATIONS WICHITA COUNTY USD 467, LEOTI, KANSAS

The Chromebook that has been issued to each 7th-12th grade Wichita County USD 467 student is the property of the Wichita County USD 467. This Chromebook is on loan to the student and must be used in accordance with the following guidelines:

- Chromebook Security Policy During the school day
 - Students must have Chromebooks with them or locked in their school lockers. Chromebook must never be left unattended.
 - o Faculty will pick up and give unattended Chromebooks to the office.
 - Chromebooks must be kept in a padded case or bag with a padded laptop compartment.
- It is recommended that Chromebooks go home with students each evening for recharging. Students are responsible for bringing their Chromebook, fully charged, to school each day.
- Students are not to deface their Chromebooks with stickers, white-out, etc. If there are any questions, check with the administrators.
- Students should protect their Chromebook from extreme heat or cold. Chromebooks should never be left in a car.
- E-mail and all other forms of electronic communication are to be used in a responsible manner. Students may not use vulgar, derogatory, or obscene language. Students may not engage in personal attacks, harassment, or bullying of others. All email sent from a USD 467 account is the property of USD 467. USD 467 reserves the right to inspect any and all e-mail messages sent from or to any USD 467 e-mail account without informing the student.
- All student Internet searches and website traffic is documented. USD 467 reserves the right to review these searches and traffic without notifying the student.
- Use of the Chromebook (including "Instant Messaging") for anything other than a teacher-directed or approved activity is prohibited during instructional time.
- The Internet is to be used for research and as a means of obtaining academically relevant information. Material obtained through research on the Internet and then used in academic work is to be properly documented. Students may not access websites, newsgroups, or chat areas that contain material that is obscene or that promotes illegal activity. If a student does accidentally access this type of information, he or she should immediately notify a teacher.
- Non-educational computer games are prohibited in classes, activity periods, and the library during regular school hours.
- Installation of peer-to-peer file-sharing programs is strictly forbidden. Software run from external drives (such as a USB flash drive) is prohibited. Using iTunes or similar programs to share music is also forbidden. Copyright laws must be respected. If a student/parent/guardian has any questions about what constitutes a copyright violation, please contact an administrator, media specialist, or language arts department person.
- If a student has a specific need for additional web applications or wants to add personal applications to the school account, he/she must request approval prior to the installation.
- Computers may not be used to make sound recordings without the consent of all those who are being recorded.
- Sound must be turned off at all times, except when being used as a part of a class.
- Students may use their own headphones to listen to music, etc., if they have the instructor's permission.
- Deliberate attempts to degrade the USD 467 network (including use of smartphones/other devices as Wi-Fi hotspots) or to disrupt system performance will result in disciplinary action.
- School administrators reserve the right to remove student accounts on the network to prevent unauthorized activity.
- Wichita County USD 467 reserves the right to define inappropriate use of technology.
- If the computer is damaged or not working properly, it must be turned in to the District Technology staff for repair.
 Parents/guardians/students are not authorized to attempt repairs themselves, or contract with any other individual or business for the repair of the laptop.
- Before a student is issued a Chromebook, he or she must have paid the necessary district fee, and both student and
 parent/guardian must have signed the Computer Acceptable Use form. If the Chromebook is stolen, vandalized or damaged in
 a natural disaster the device fee will cover a portion of the replacement cost providing that a police report is filed on the
 incident. Lost power cords are not covered and are the responsibility of the student/parent.
- It is recommended that student owned Internet capable devices (iPads, tablets, etc.) be left at home. If a student brings such a device, the use of that device falls under the cell phone/electronic/computer use in the USD 467 Student/Parent handbook.

STUDENT CHROMEBOOK LOAN AGREEMENT USD 467, LEOTI, KANSAS

Providing Chromebooks for instructional use by USD 467 students is an exciting venture. Certain guidelines are necessary to protect the laptop and the school network and ensure that this technology serves as an effective instructional tool. Students and their parents/guardians must agree to the following:

- 1. The student agrees to follow all USD 467 regulations and policies governing the use of computers as well as all applicable State and Federal laws including copyright and intellectual property law pertaining to software and information.
- 2. This equipment is the property of Wichita County, USD 467, Leoti, Kansas and is herewith being loaned to the student for educational purposes only for the academic school year. The student may not deface or destroy this property in any way. Inappropriate material on the machine may result in the student losing their right to use this computer.
- 3. The student will have a Chromebook checked out at the beginning of school when necessary fees have been paid. The computer will be checked-in on the last day of school in May.
- **4.** The Chromebook is the property of USD 467. If a student withdraws from school prior to the end of the loan period, the Chromebook is to be returned to school officials by the student prior to withdrawal.
- 5. Chromebooks not returned in an appropriate manner will be filed as missing and turned over to the proper authorities as theft.
- **6.** The student shall not remove or alter any USD 467 identification labels attached to or displayed on the Chromebook, nor shall the student change identification within the Chromebook such as the Chromebook name.
- 7. The student agrees to handle the computer carefully and protect it from potential sources of damage.
- **8.** The student will assume the risk of loss by theft, destruction, or damage. Any and all damage to the Chromebook while assigned to the student is the responsibility of the student and parent/guardian. Lost power cords are the responsibility of the student/parent. If the Chromebook is stolen, vandalized, or damaged in a natural disaster the device fee will cover a portion of the replacement cost providing that a police report is filed on the incident. By signing the loan agreement, the parent /guardian agrees to be responsible for each occurrence involving loss/damage to the Chromebook, or the cost of repair for such damage, while in the student's possession. Any Chromebook reported stolen without filing a police report will result in payment of full replacement cost of the Chromebook which, at this time, is \$300.
- **9.** The student must report theft (or suspected theft) of the Chromebook, loss of the Chromebook, damage to the Chromebook, or malfunctioning of the Chromebook to school personnel immediately.
- **10.** The student and parent agree to indemnify USD 467 against any claim, suit or damage occurring during or resulting from student possession or use of the Chromebook including but not limited to any claim for infringement or violation of applicable trademarks and copyrights attributable to student's use of the District's Chromebook.
- **11.** Upon request, the student agrees to deliver the Chromebook to USD 467 staff for technical inspection or to verify inventory or other information including random screening.
- 12. USD 467 is not liable for lost data or time spent on data.
- **13.** The student shall not alter or remove any software provided by USD 467; nor, actually or causally, add, use, run, operate, or install any software other than what is provided by USD 467.

I have read and agree to abide by all USD 467 policies and regulations for the use of equipment including the Acceptable Use Policy Agreement and the Student Chromebook/E-mail/Internet Regulations. I accept responsibility for damage to or loss of the equipment listed below while in my possession. I understand that if the Chromebook or any accessory is lost, damaged, or stolen, I am responsible for the replacement cost. I will report any damage to hardware or software immediately to designated school personnel and will return equipment promptly when requested by school personnel.
